#### **ORDER**

Now before the Arkansas State Claims Commission (the "Claims Commission") is the motion filed by the Arkansas State Police (the "Respondent") to dismiss the claim of Anthony Williamson (the "Claimant"). Based upon a review of the motion and the law of Arkansas, the Claims Commission hereby finds as follows:

- 1. Claimant filed his claim on January 6, 2020, alleging that certain items were wrongfully kept by Respondent after being seized on July 16, 2007.
- 2. Respondent filed a motion to dismiss, arguing that Claimant's claims are barred by the applicable three-year statute of limitation. Ark. Code Ann. § 16-56-105.
  - 3. Claimant did not respond to the motion, but he did file discovery requests.
- 4. After reviewing the pleadings, the Claims Commission agrees with Respondent that Claimant's claim is time-barred pursuant to Ark. Code Ann. § 16-56-105.
- 5. Respondent's motion to dismiss is GRANTED, and Claimant's claim is DENIED and DISMISSED.

# ORDER ON CLAIMANT'S MOTION FOR RECONSIDERATION

Now before the Arkansas State Claims Commission (the "Claims Commission") is a motion filed by Anthony Williamson (the "Claimant") for reconsideration of the Claims Commission's February 20, 2020, order dismissing Claimant's claim against the Arkansas State Police (the "Respondent"). Based upon a review of the pleading, the arguments made therein, and the law of Arkansas, the Claims Commission hereby unanimously finds as follows:

- 1. Claimant filed his claim on January 6, 2020, alleging that certain items were wrongfully kept by Respondent after being seized by Respondent on July 16, 2007.
- 2. Respondent filed a motion to dismiss, arguing that Claimant's claims are barred by the applicable three-year statute of limitation pursuant to Ark. Code Ann. § 16-56-105. The Claims Commission agreed and granted Respondent's motion.
- 3. Claimant thereafter filed the instant motion for reconsideration, arguing that his claims are not time-barred.
- 4. In analyzing a motion for reconsideration, Rule 7.1 of the Claims Commission Rules and Regulations states that motions for reconsideration "will only be entertained if they set forth new or additional evidence which was not [previously] available . . . ."
- 5. The Claims Commission finds that the motion does not set forth new or additional evidence not previously available. Claimant's property was seized in 2007, and Claimant did not file a claim until 2020.

6. As such, Claimant's motion for reconsideration is DENIED, and the February 20,

2020, Claims Commission order remains in effect.
