Page 2, line 7, delete "_____\$190,000,000" and substitute with "____\$215,000,000"

Page 2, line 30, delete "<u>\$205,000,000</u>" and substitute with "<u>\$230,000,000</u>" AND

Page 2, line 32, delete "REVENUES" and substitute with "REVENUES - COUNTIES"

AND

Page 3, line 6, delete "_____\$10,000,000" and substitute with "____\$15,000,000"

AND

Page 3, immediately following SECTION 5, insert the following:

" SECTION 6. APPROPRIATION - UNANTICIPATED SPECIAL REVENUES - CITIES.
