Attached arc my recommendations for reappropriation of various infrastructure projects for the 2015-2017 Biennium. The recommendations are separated by fund accounts for your review.

My recommendations for the 89th Session Projects Account (KBQ) reflect the anticipated need for appropriations for capital projects requested by the agencies and institutions. As of January 5, 2015 a total of \$362.8 million has been released from both the Executive and Legislative Divisions during the current biennium.

All other projects have been requested pursuant to agency review.

Projects funded in accordance with the provisions of A.C.A. §19-5-1004(c), which allows the Technical Institutes to retain year-end fund balances, have been reappropriated at levels requested by the Institutes.

I would appreciate your introducing these requests as Joint Budget Committee Bills.
