NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>TRANSFER</u> <u>PROCEDURES - MEDICAL MARIJUANA IMPLEMENTATION AND REGULATION. In the event</u> that sufficient appropriation is not provided by the General Assembly for <u>expenditures resulting from the implementation and regulation of the Arkansas</u> <u>Medical Marijuana Amendment of 2016 for any state agency, pursuant to</u> <u>Arkansas Code § 19-4-701 et. seq., said agency shall request a transfer of</u> <u>appropriation from the Chief Fiscal Officer of the State, stating clearly the</u> <u>amount required. Upon approval of the Chief Fiscal Officer of the State said</u> <u>appropriations shall be established upon the books of the Department of</u> <u>Finance and Administration in compliance with the applicable classifications</u>
