SECTION XX. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. POSITION REQUIREMENTS. The Operations Manager shall hold and maintain a Certified Public Accountant license in good standing in the state of Arkansas. The Internal Auditor shall hold and maintain an active certification as a Certified Internal Auditor, with the Institute of Internal Auditors, or a Certified Public Accountant license in good standing in the state of Arkansas.

The provisions of this section shall be in effect only from July 1, 2022 through June 30, 2023.
