In July of 2017, through open communication with my supervisor, Cassandra Mayfield, and her supervisor Ben Udochi, I was made aware of the error, and then later confirmed with HR staff Tiffany Gaston, that I had never received my 6% increase. Based on this discovery and my exemplary performance of my duties, I can find no reason why this claim should not be granted.
