The college of Education & Health Professions of UAF & the College of Health Professions at UAMS have been approved for the development of a post-baccalaureate education program leading to a Doctor of Occupational Therapy, to be jointly located at the UAF & UAMS Northwest campuses in Fayetteville, AR. The first 24 students are scheduled to begin in fall 2018. A minimum of one dedicated classroom and four lab facilities, primarily assigned to the OT program, are required. Access to a second classroom will be required with the enrollment of multiple cohorts. All rooms will be equipped with technology for instruction. Lab space includes a physical rehabilitation lab, an activities of daily living (ADL) lab, an assistive technology lab, and a pediatric play lab. At UAF, renovations to an existing house will create a learning & lab space for 'in-home' simulations of daily occupants. The house will also be renovated to include offices for the seven new faculty members and staff.
