The Arkansas Legislative Council approved twenty-four grants for the Arkansas CASA programs on May 15th after the May 12th Review Subcommittee meeting. The approved grants included a \$29,000 grant to CASA of Phillips County for court-appointed advocacy services in the First Judicial District. On Friday, September 4, 2015, the board of directors for CASA of Phillips County elected to dissolve their program effective September 30, 2015.

At this time there are grant funds remaining in the amount of \$21,750 to be disbursed for advocacy services in the First Judicial District for this grant cycle. Two local CASA programs, CASA of Crittenden County and CASA of Lonoke County, have agreed to provide services in the counties of the First Judicial District for the remainder of this grant cycle. Accordingly, we will be disbursing \$14,500 to CASA of Crittenden County to deliver services in Cross, St. Francis, Lee and Phillips Counties and \$7,250 to CASA of Lonoke County to deliver services in Woodruff and Monroe Counties.
