

Arkansas Historic Preservation Program

Selection process: The American Battlefield Protection Program (ABPP) of the National Park Service reviews applications for acquisitions funds from across the U.S. and assesses the various projects before selecting which Civil War battlefield acquisition projects to fund. The Arkansas Historic Preservation Program will be the state sponsor for this grant, which will pass through to the Civil War Trust. The Civil War Trust is contributing 10% of the purchase price of the battlefield and they are the preeminent authority on acquisition of Civil War sites across the country. They were instrumental in completing the application to the ABPP and have been identified as a partner in this acquisition since its inception. They have worked with AHPP and the National Park Service to develop an easement that will satisfy the requirements set forth in the federal regulations for the ABPP.

Purpose or grant description: The Arkansas Historic Preservation Program (AHPP) has been working with the Nevada County Depot Museum in Prescott to raise funds to purchase 448 acres of the Elkins' Ferry Battlefield in Nevada County from Hancock Property Management with a goal of developing the battle site as a heritage tourism destination. Working with a variety of local, state and national partners, the local museum raised more than \$496,000, making them eligible for federal LWCF acquisition funding through the American Battlefield Protection Program of the National Park Service, which the AHPP will pass through to the Civil War Trust to complete the acquisition before the end of 2015. After the AHPP transfers the funds to the Civil War Trust, they will make the purchase with all of the combined funds, donate an easement on the entire area purchased to the AHPP, and then transfer title to the property to Nevada Depot Museum.
