The Arkansas Legislative Council Review Subcommittee approved twenty-four grants for Arkansas CASA programs on June 14, 2016. The approved grants included a \$40,000 grant to CASA of Arkansas County for court-appointed volunteer advocacy services in Arkansas County. On August 25, 2016 the board of directors for CASA of Arkansas County elected to dissolve their program effective September 30, 2016.


None of the \$40,000 awarded to CASA of Arkansas County for 2016-2017 has been disbursed due to their failure to abide by state and national CASA standards. CASA of Lonoke County has assumed responsibility for provision of volunteer advocacy services in Arkansas County. CASA of Lonoke County is currently providing said services and will continue to do so for the remainder of this fiscal year. Accordingly, we would like to reallocate \$40,000 for services in Arkansas County/11E Judicial District to CASA of Lonoke County to provide volunteer advocates to abused and neglected youth.
