EXECUTIVE RECOMMENDATION

EXTRA HELP RESTRICTION. No extra help employee of Disability Determination for Social Security Administration shall be employed for a period of time to exceed eighteen hundred (1800) hours in any single fiscal year.

The provisions of this section shall be in effect only from July 1, ~~2016~~ 2017 through June 30, ~~2017~~ 2018.
