The Department of the Military is requesting Various Temporary Appropriation under Act 796 of 2023, Section 33, in the amount of \$950,000. This appropriation will allow the Agency to match the Federal Cooperative Funding Agreement to maintain and update the National Guard Armories around Arkansas, Camp Robinson buildings, and Fort Chaffee buildings. The appropriation of \$850,000 will need to be added to Business Area 0975, Fund HMD0100, Funds Center 268 and Commitment Item 502:00:02. The appropriation of \$100,000 will need to be added to BA0975, Fund HMD0600, Funds Center 268, and Commitment Item 506:00:10. Funding for this request is provided by General Revenue. This will not result in an increase of General Revenue as an equal budget adjustment within Military's allocation will be completed to ensure available budget is within the funding allotment.
