The Department of Public Safety – Division of Commission on Law Enforcement Standards and Training (CLEST) is requesting to reallocate ARPA funding within its current ARPA projects that was approved during the September PEER meeting. CLEST is currently in the planning and design phase of the Camden Campus and Northwest Campus upgrades project. The Camden project is updating/renovating the current facility that dates back to 1969, renovating existing student barracks and adding a new covering to the existing firing range.
