Dear Mr. Hudson:

The Arkansas Department of Parks, Heritage, and Tourism, Division of Arkansas State Parks requests a Cash Appropriation increase for the division's Cash Operations FY2025 appropriation.

The department is requesting an increase for FY2025 of \$1,755,000 in Commitment Item 502:00:02 Operating Expenditures and \$1,625,000 in Commitment Item 506:00:10 Professional Fees, Fund NPT0104 and Fund Center 986.

The additional operating appropriation is needed to facilitate the expenditures associated with the implementation of the reservation and point of sale system. The current system lacks the features necessary to meet the increasing demands of our business operations. The new system will allow us to process transactions more efficiently, manage inventory better, and generate real-time sales data for improved decision-making. The new system is expected to grow the state park operating revenue.

As part of the professional fees appropriation request there will be a comprehensive redesign of our website. The current website does not adequately represent our brand or offer the functionality needed to support the new POS and reservation systems. A redesigned website will provide a more user-friendly interface, better integrate with the new systems, and enhance our online presence. A competitive analysis was conducted on the current website indicating significant shortcomings.

Fortunately, due to increased visitation and sales, ADPHT has sufficient cash revenues to increase this commitment line item. Respectfully, we are asking that the additional appropriation request be placed on the next PEER Committee agenda.
