The Arkansas Department of Parks, Heritage and Tourism, Mosaic Templar Cultural Center, is requesting an increase in our Cash Fund Appropriation due to continued donations from several funding sources/grants to our Capital Campaign (Union Pacific Charitable Foundation, 100 Black Men, Loblolly Creamery, Velvatex, AT&T, Arkansas Black Hall of Fame). Mosaic Templar Cultural Center has developed an interpretive plan that will allow the center to remain a welcoming space to learn while engaging increasingly diverse and complex audiences. The fully updated space re-envisions a ten-year-old educational exhibit to embrace inclusivity and widens the centers focus to reflect and share the complete story of black Arkansans from across the state. The agency is requesting the increase to cover ongoing fundraising for the project

The agency is requesting an increase of \$446,860 in Commitment Item 46 Miscellaneous, Fund NNH0910, Fund Center U41, and Business Area 0865 to cover the receipt of these funds. The agency will place any portion of the funds related to construction in a method of finance and assign a separate sub-fund center for tracking.

Pursuant to the provisions of Section 28 of Act 1006 of 2019, Cossatot Community College of the University of Arkansas (CCCUA) requests a transfer of cash appropriation from the DFA Cash Fund Holding Account to CCCUA's Cash Operations appropriation for FY2020 for the following amount:

Personal Services Matching:

\$1,000,000

Due to an error in requested amounts in the biennial forms, CCCUA will be short in cash appropriation to pay benefits for employees during the FY2020 year. This error has left us with insufficient levels of cash appropriation for Personal Services Matching. Therefore, an increase is necessary to provide CCCUA with sufficient authority to process the required benefit payments, such as insurance, retirement and FICA taxes for the remainder of the year.

I ask that this request be placed on the agenda for consideration by the Performance Evaluation and Expenditure Review (PEER) Committee of the Arkansas Legislative Council at the earliest date possible.
