The appropriation needed for the Declining Enrollment program represents the amount needed to complete FY20 Declining Enrollment payments to school districts pursuant to ACA 6-20-2305(a)(3)(A). Declining enrollment funding is the difference between the average of the two (2) immediately preceding years' average daily memberships and the average daily membership for the previous school year multiplied by the amount of foundation funding. School districts are prohibited from receiving both declining enrollment funding and student growth funding during the same fiscal year.
