COURT ORDER/SETTLEMENT AGREEMENT/CASH FUNDS RECEIVED DURING QUARTER

- **Grand River Enterprises**

State of Arkansas v. Grand River Enterprises - Counsel for the Attorney General worked with Grand River to obtain a Settlement Agreement for Arkansas Assurance of Voluntary Compliance for their not complying with Arkansas's tobacco statutes.

- **C.R. Bard, Inc.**

State of Arkansas v. C.R. Bard, Inc. Multistate Investigation - Multistate investigation of deceptive marketing (failure to warn) and failing to obtain product approvals of permanently implanted Surgical Mesh in men and women to support weakened muscles and prolapsed organs.

- **Centene Management Company, LLC**

State of Arkansas v. Centene Corporation, et.al. - Centene and its subsidiaries were alleged to have overcharged the State of Arkansas for medications in its Medicaid program. To settle the claims, Centene must pay \$15,228,318 to the State of Arkansas in two installments within the next year. Going forward, Centene has agreed to provide full transparency related to the adjudication and payment of all pharmacy benefit claims.

- **Jean Butler**

Jean Butler facilitated a multi-million dollar international sweepstakes scheme. Ms. Butler received funds from victims of the scam and funneled money to operators of the scheme in Jamaica.

- **Harrison Company, LLC**

Arkansas Attorney General's Office negotiated an *Assurance of Voluntary Compliance* with Harrison Company, LLC, to refrain from selling, offering, or possessing for sale in the State of Arkansas any cigarettes of a tobacco product manufacturer or brand family that are not included in the Approved-for-Sale Tobacco Products Directory maintained by the Attorney General.

- **James Read-Snowbirdbob, LLC**

Arkansas Attorney General's Office negotiated an *Assurance of Voluntary Compliance* with James Read d/b/a Snowbi10 on EBay to remit full refunds of costs and shipping to 173 consumers who purchased from Respondent in violation of price-gouging law.
