Mr. Weiss:

In accordance with Section 34 of Act 285 of 2014, the Arkansas Game & Fish Commission requests cash appropriation in the amount of \$18,000,000. This is for funds from the settlement of the Black River Wildlife Management Area Timber lawsuit, funds that are dedicated to the restoration of the damaged hardwoods within the management area; the funds will be from damages received from the United States Treasury.

A new SDG – Game Protection appropriation (M99 – Black River Settlement) was requested in the biennial request for the Fiscal Years 2016 and 2017 and these funds will be moved to the new fund in the biennium. We are requesting cash appropriation in order to begin work prior to Fiscal Year 2016.
