Please approve the request to transfer Appropriations based on our Act 280 for the 2014-2015 fiscal year in Section 20, Transfer of Appropriation.

Please transfer as follows:

SECTION 3. Appropriation – Unemployment Benefits and Expenses – Cash

The appropriation to be transferred is from UI benefits for tax rated employers (C29). We have a total of \$600M of appropriation, this will still leave ample appropriation for payment of UI tax rated benefits. This request for a transfer of appropriation from C29-UI Benefits will ensure that DWS has the sufficient appropriations in 1770200 C27C to repay the remaining balance of the Title XII Advances in SFY15.

In Act 280, Section 3 - UI Advance Repayment C27C, and Item No. 07 for the 2014-2015 FY, DWS has an appropriation amount of \$50,000,000. This request of an additional \$4,000,000 would increase C27C to \$54,000,000.

Act 280, Section 7 - UI Trust Fund Interest/Unemployment Insurance-TZR0000-2SFL-Loan Interest- for the 2014-2015 FY, DWS has an appropriation amount of \$21,000,000. This request of an additional \$51,000,000 would increase TZR0000 2SFL to \$72M. This additional appropriation is needed to ensure enough appropriation is in place for the "roll over" of the excess Advance Interest Funds on November 10th required by ACA§11-10-708. In order to get the excess money for the Advance Interest Trust Fund the law requires that a warrant be created and to create a warrant there must be a sufficient appropriation.
