HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,851.3 million have increased \$215.8 million, or 3.8%, above the \$3,635.5 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$335.9 million increased \$20.5 million, or 6.5%, from the \$315.4 million available for distribution in May 2014. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,251,485.28 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$24,766.338.08.


