

RE: Cash Fund Increase; Delta Heritage Trail State Park (DHTSP)

Dear Mr. Sharp:

The Arkansas Department of Parks and Tourism, State Parks Division, is requesting an increase in our Cash Fund Appropriation for construction of additional hike/bike trail at DHTSP. Our request will comprise continuation of the construction of the subject 87 mile rails to trails project in East Arkansas.

When the trail right-of-way was acquired from Union Pacific Railroad in 1992, 33 miles of rail on the north end of the trail was acquired for potential use by a private excursion trail operator for eco-tours. Crossing the White and Arkansas Rivers through the White River National Refuge and AGFC's Trusten Holder Wildlife Management Area, passengers would experience some of the last of Arkansas's original bottomland hardwoods. With no response to the RFP, the State Parks, Recreation and Travel Commission voted to sell the rail.

In 1992 the rail was acquired for \$600,000 with Federal Highway Administration (FHA) Funds and it sold in 2012 for \$5,773,317. In accordance with FHA regulations, the proceeds from the rail sale must be used on the trail project. Construction plans have been completed to utilize the rail funds for building hike/bike trail on the DHTSP from Arkansas City to the Arkansas River. Rail proceed funds have been expended on the trail project, to include a \$4.4 million construction contract that commenced November 5, 2014. Due to winter weather and above average 2015 spring rains, the project has been delayed and will not be completed in FY 15. Therefore a cash fund appropriation for FY 16 will be necessary to complete the construction contract.

Dear Mr. Walther:

By this letter, I am requesting the continuation of the treasury cash fund appropriation for payments to be made under the Arkansas Energy Performance Contracting Program (AEPC) within the Arkansas Economic Development Commission (AEDC) for the fiscal period beginning July 1, 2015.

The original cash fund appropriation for this program was established following review by the Performance Evaluation & Expenditure Review (PEER) Committee in October, 2014. We would now would like to continue the appropriation in order to continue the program with existing funding.

We request appropriations in the amount of \$100,000 for Professional Fees and Services (character code 10) and \$10,000 for General Operations (character code 02).

In 2013, the 89th General Assembly amended the Guaranteed Energy Cost Savings Act (ACA 19-11-1201) with Act 554 Of 2014, which requires the Arkansas Energy Office to establish rules that sets the standards and govern the process by which state agencies engage Energy Service Companies (EPCs) to pursue guaranteed energy cost savings contracts, also known as energy performance contracts with state agencies.

The AEDC has now developed the AEPC framework for agencies to successfully complete comprehensive energy upgrades using EPCs. This framework and the policies included in it were reviewed by the ALC-Administrative Rules and Regulations 5ubcommittee in June, 2014.

This appropriation is necessary to allow the Arkansas Energy Office to administer the energy performance contracts and to assure that state agencies receive the guaranteed savings that they have contracted for.

Dear Mr. Walther:

By this letter, I am requesting continuation of the Treasury Cash Fund appropriation for rebates under the Gaseous Fuels Rebate Program within the Arkansas Energy Office (AEO) which was submitted to, and successfully reviewed by the Performance Evaluation and Expenditure Review (PEER) Committee of the Legislative Council at their June 2014 meeting and continued again in September of 2014. I am asking for continuation of the balance of \$1.6 million for the fiscal period beginning July 1, 2015.

We received grants from the Northwest Arkansas Economic Development District (NWAEDD) for the purpose of funding projects in Northwest Arkansas under the Gaseous Fuels Rebate totaling \$1.815 million for alternative fuel filling stations and to offer rebates to vehicle owners across the entire state who wish to purchase or convert to clea burning fuels on private and fleet vehicles.

The AEO is now attempting to secure further funding for similar projects around the state. The sources of this additional funding have expressed a desire to pass the funding through the AEO's Gaseous Fuels Rebate Program rather than trying to create a duplicate program in another agency, therefore, we feel this request is the best approach to cover all known proposals.

The rebates allowed under the program are for \$4,500 or fifty percent (50%) of the conversion/incremental cost; whichever is the lesser, for vehicles and \$400,000 or 75 percent (75%) of the construction cost, whichever is the lesser, for refueling stations.

The rebates are part of the requirements of Act 532 of 2013 for the statewide program.

ArkansasIDEAS is a partnership between the Arkansas Department of Education (ADE) and AETN to provide access to high quality, online professional development for Arkansas licensed educators. In order to manage the standard workload, one C116 extra help position was hired. Due to increased production projects with ADE, and the implementation of a new learning management system to better serve Arkansas educators, our current workload has more than doubled in the past 12 months and is at maximum capacity. Also, staff changes at ADE have created the need for additional quality control and standard assurance responsibilities for ArkansasIDEAS. To meet the expanding job duties, three additional C116 extra help positions have been hired. Without the additional staff, there are multiple scheduled projects that would be in jeopardy of falling behind. These projects include professional development for teachers to support computer coding classes for high schools (ACT 187) and ADE emergency rules governing educator licensure (February 12, 2015). An increase in extra help appropriation is necessary to ensure that services are maintained for the teachers of Arkansas.

Act 623 of 2013 amended Arkansas Code provisions to require the Department of Finance and Administration (DFA) to collect the existing E911 service charges levied on sales of prepaid wireless mobile radio (cell phone) telecommunications services effective January 1, 2014. The fee is levied on prepaid wireless telephone service sold by a retailer and is currently imposed at the rate of sixty-five cents (\$0.65) per retail transaction. The fee is collected by the retailer on each recharge of the prepaid cell phone. The bill requires retailers to collect the fee on prepaid wireless services at point of sale and remit the fee collections to DFA.

The fees collected have exceeded the original appropriation estimates. Additional Cash Fund Appropriation is now requested for Fiscal Year 2015-16 so that DFA can remit the receipts to the Arkansas Emergency Telephone Services Board.
