State of Arkansas v. Ameracard Enterprises, Inc. and Joseph Cassara, Pulaski County Circuit Court, \$1,500 recovered this quarter. Counsel for the Attorney General worked with opposing counsel to jointly draft an agreement resolving Ameracard's deceptive business practices.

In Re: Electronic Books Antitrust Litigation Apple exhausted its appeal of the State's judgment resolving its price-fixing actions triggering the payment.

State of Arkansas v. Grand River Enterprises Counsel for the Attorney General worked with Grand River to obtain a settlement agreement for noncompliance with Arkansas's tobacco statutes.

In Re MoneyGram Counsel for the Attorney General worked with counsel for MoneyGram to resolve Defendant's unconscionable business practices.
