# Case Name of Court Order or Settlement Agreement and the amount of fund received by the Office of the Attorney General for each Court Order or Settlement Agreement during the quarter:

#### DRAM:

California, et al. v. Infineon Technologies, et al. – Arkansas and a number of other states sued Defendants for antitrust violations. Arkansas received \$50,711.74 as reimbursement of fees and costs at the conclusion of the case.

#### Grand River Enterprises

State of Arkansas v. Grand River Enterprises — Counsel for the Attorney General worked with Grand River to obtain a settlement agreement for noncompliance with Arkansas's tobacco statutes.

#### Tri-State Pawn of Texarkana

State of Arkansas v. Tri-State Pawn of Texarkana — Counsel for the Attorney General worked with Tri-State Pawn's counsel to obtain a consent judgment resolving Tri-State Pawn's unconscionable business practices.

#### Volkswagen Group of America

State of Arkansas v. Volkswagen, et al. — Counsel for the Attorney General and and other state attorneys general worked with Volkswagen's counsel to obtain a consent judgment resolving Volkswagen's deceptive business practices.

#### Western Union Financial Service

In the Matter of The Western Union Company — Counsel for the Attorney General and other state attorneys general worked with Western Union's counsel to obtain an assurance of voluntary compliance resolving Western Union's unconscionable business practices.
