Dear Senator Boyd and Representative Lynch:

Pursuant to special language in Act 206 of 2022, the Administrative Office of the Courts (AOC) submits this letter explaining the appropriation request regarding official court reporters (OCRs), trial court administrators (TCAs), and juvenile court probation officers (JCPO) collectively referred to as trial court employees (TCEs).

Trial court employees are state employees who serve each county throughout Arkansas. Due to particular funding restraints, this category of employees has, at times, not received the same performance pay and cost of living adjustments as their colleagues in other state agencies. In response, the General Assembly elected to fix this problem by passing Act 206 of 2022 wherein the legislature requires a capped amount of funding to be transferred from the Administration of Justice Fund to State Central Services. The funding for future salary growth is derived from State Central Services. These changes allow TCEs to be treated like their state colleagues for salary purposes.

In 2022, TCEs received the same two-percent cost-of-living adjustment and five-percent performance pay increase as did all state employees. At the direction of the governor, the state increased its mileage reimbursement rate from \$0.42 to \$0.52 per mile. This change, combined with an increased demand for contractor/substitute court reporters and the rising travel and meal reimbursement costs created by inflation, leads to a request for additional appropriation to cover contractor/substitute court reporters. Therefore, the AOC is requesting the following additional appropriation:

Pay Plan for Juvenile Drug Court Officers

Approved December 2, 2019

This pay scale plan is not a guarantee or promise of salary increases. The Administrative Office of the Courts reserves the right to suspend or halt scheduled raises for budgetary reasons.

Pursuant to the latest reorganization of the State of Arkansas's Employee Classification System, juvenile drug court officers are classified as GS06 positions. The compensation range for GS06 is \$36,155 to \$52,425 annually. This schedule is prepared in an attempt to bring uniformity and predictability to the process of the pay scale and to incentivize employees to obtain relevant experience and educational achievements to better serve our courts and, in turn, better serve the citizens of our state.

The plans are based on a thirty (30) year career path with the State of Arkansas. Employees are rewarded for their service by earning "steps" in the pay scale for their job performance, educational achievements, and relevant work experience. This pay scale is to be applied only to juvenile drug court officers.

Pay Plan for TCAs and Certified Court Reporters

Effective August 1, 2021

This pay scale plan is not a guarantee or promise of salary increases. The Trial Court Employee Committee reserves the right to suspend or halt scheduled raises for budgetary reasons.

Pursuant to the latest reorganization of the State of Arkansas's Employee Classification System, Trial Court Administrators (TCAs) are classified as GS07 and Court Reporters as GS08 positions. The compensation range for GS07 is \$40,340-\$58,493 per year and the compensation range for GS08 is \$45,010-\$65,265 per year. These schedules are prepared in an attempt to bring uniformity and predictability to the process of the pay scale and to incentivize employees to obtain relevant experience and educational achievements to better serve our courts and, in turn, better serve the citizens of our state.

The plans are based on a thirty (30) year career path with the State of Arkansas. Employees are rewarded for their service by earning "steps" in the pay scale for their job performance, educational achievements, and relevant work experience. This pay scale is to be applied only to TCAs and Court Reporters.

The Administrative Office of the Courts (AOC) shall promulgate any changes to this Plan to all trial court employees and circuit judges.

 - Obtaining and maintaining in good standing Registered Merit Reporter (RMR) by the National Court Reporters Association (NCRA) OR Certificate of Merit (CM) by the National Verbatim Reporters Association (NVRA) OR Certificate of Merit Stenotype (CM-S) by the National Verbatim Reporters Association (NVRA) OR Certificate of Merit Master (CM-M) by the National Verbatim Reporters Association (NVRA).
