The federal Digital Equity Act (DEA) created three separate grant programs and was authorized by the Infrastructure Investment and Jobs Act of 2021. The first grant, the DE Planning Grant Program, funded the development of Arkansas' Digital Skills and Opportunity Plan. The second grant, the DE Capacity Grant Program, provides funding to implement the state's Digital Skills and Opportunity Plan, with programmatic focus on digital skills training and digital device distribution initiatives, among other potential efforts. The Arkansas State Broadband Office received \$10,161,429.01 through the DE Capacity Grant Program.

As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project.

24. Monitoring and Compliance

Awarded projects are subject to project monitoring, the purpose of which is to ensure recipients fulfill the terms and conditions of their awards. The Grantee must comply with all monitoring and information requests from NTIA within the timeframe specified by NTIA. If the Grantee fails to comply with monitoring and information requests, NTIA may determine that the Grantee is non-compliant with award terms and conditions.
