The Arkansas Department of Public Safety, State Crime Laboratory is requesting Various Temporary Appropriation authorized under Section 34 of Act 2 of 2020, in the amount of \$250,000. This appropriation will allow the medical examiners to contract with locum tenens. In order to address the current demands for autopsy requests from coroners and law enforcement agencies throughout the state, the locum tenens who are forensic pathologists would be working temporarily as contract employees. These pathologists would be contracted to conduct autopsies on non-criminal cases that are submitted to the laboratory requiring forensic examinations.

The Arkansas State Crime Laboratory's Medical Examiner section is accredited by the National Association of Medical Examiners (NAME). This accreditation is a way for our laboratory to objectively demonstrate that we are conforming to national standards and that we meet and exceed the expectation of our citizens. This also provides confidence to the criminal justice system when we offer our scientific expert testimony regarding our results. Accreditation requires that no forensic pathologist perform in excess of 250 autopsies per year. Currently, the Arkansas State Crime Laboratory performs approximately 1,500 autopsies per year. In 2019 our forensic pathologists averaged 290 cases each, exceeding the required upper limit. Should the number of autopsies continue to increase, coupled with the inability to recruit and retain employees, our NAME accreditation will be in jeopardy. If the Medical Examiners section loses accreditation, homicide cases will be more difficult to obtain convictions and our credibility will be questioned.
