### **JUSTIFICATION**

This position is tasked with supervising human resources, training, finance, communications, and Legal Services. As the second in command to the Secretary of Corrections, the incumbent of the new title will be tasked with directly supervising information technology, policy development, criminal detention facilities review, and offender database development and research. The DOC Chief of Staff will also participate in a management planning team to formulate and implement department policies and long-range goals/objectives for the accomplishment of the agency's mission. Therefore, the agency requests the new title and the appropriate grade based on the duties associated with the classification.

Dear Ms. Barnhill,

The Transformation and Efficiencies Act of 2019 created the Department of Corrections (DOC) as a cabinet level department. The DOC is comprised of the Division of Correction, Division of Community Correction, Arkansas Sentencing Commission, Arkansas Correctional School System, Criminal Detention Facilities Review Committees, the Parole Board, and the State Council for Interstate Commission for Adult Supervision. Combined, the DOC has over 6,0000 authorized positions.

After the passage of the Transformation and Efficiencies Act, cabinet level departments established the Chief of Staff position. For the DOC, the Chief of Staff is the second in command to the Secretary of Corrections. Currently, the Chief of Staff directly supervises Information Technology, Policy Development, Criminal Detention Facilities Review, and Offender Database Development and Research. Indirectly, the position supervises Human Resources, Training, Finance, Communications, and Legal Services.

In the past, the DOC used existing GS position titles for the Chief of Staff. The DOC is requesting a new title of DOC Chief of Staff with a grade of SE04. The cost of this request is approximately \$195,000, inclusive of salary, matching, and benefits. The DOC has sufficient funding to support this pool position request.
