Dear Senator Davis and Representative Wooten:

The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Corrections (DOC), Division of Community Correction (DCC) for your review.

DCC is requesting a special entry rate of \$105,000, which is between midpoint and maximum of pay grade GS13, for an exceptionally well qualified applicant for the classification G019C, General Counsel.

Vincent France's background includes a Juris Doctorate as well as fourteen (14) years of work experience. The following is a detailed comparison of the minimum qualifications of the classification and Mr. France's experience.

MINIMUM REQUIREMENTS:

The formal education equivalent of a law degree from an accredited law school; plus six years of experience in public sector law, including three years of litigation experience.

Must be licensed to practice law and admitted to the Arkansas State Bar in accordance with ACA § 16-22-201.

JUSTIFICATION:

Statewide, there are seven (7) positions classified as General Counsel with an average annual salary of \$100,473.09 and 15.12 years of state service. Of these seven (7) positions, none are located within the Arkansas Department of Corrections. The statewide turnover rate for this classification was two (2) out of nine (9) positions or 22.22% within the previous year. There is no agency turnover rate for this classification.

Mr. France is currently employed through the Arkansas Attorney General's Office as an Attorney General V with an annual salary of \$100,950.10. His responsibilities within the Attorney General's Office include investigating claims, preparing defense arguments, presenting defense arguments at trial, taking and defending depositions, serving as lead attorney in jury trials, as well as writing appellate briefs. His forthcoming position within DOC should necessitate functioning as their lead legal resource.

RECOMMENDATION:

The Office of Personnel Management **recommends** the requested rate of \$105,000, which is between midpoint and maximum of pay grade GS13, for the classification G019C, General Counsel.
