Dear Chairman Dismang and Chairman Jean,

I am respectfully requesting the following changes be made to HB1135 for the Office of the Attorney General. This proposed amendment will decrease the overall appropriation for the Office of the Attorney General and save \$10,021,666—a) \$21,666 savings from Section 3 Appropriation – Operations and Section 8 Appropriation – Medicaid Fraud Division – Federal as well as b) \$10,000,000 savings from Section 13 Appropriation – Cash Funds – Settlement Fees. This proposal reflects my decision to restructure and streamline the Office of the Attorney General based upon a comprehensive review and in-depth analysis of the Office's historical appropriations and spending. My proposed changes are outlined in this letter and detailed in Exhibit A.

**Section 1.** Regular Salaries – Operations. These changes include an increase in the maximum number of employees, an increase in the appropriation for salaries and a reduction of job titles from forty (40) to fifteen (15).

**Section 2.** Extra Help – Operations. Delete this section in its entirety.

**Section 3.** <u>Appropriation – Operations.</u> Regular salaries and personal services matching will change due to an increase in the appropriation for salaries. Maintenance and general operation expenses will decrease because lease payments, conference and travel expenses, professional fees and capital outlay will mostly be paid from Cash Funds – Settlement Fees.

**Section 4.** Regular Salaries – Medicaid Fraud Division – State. These changes include one additional position, an increase in the appropriation for salaries and title changes. Additional staffing is necessary to combat potential fraud due to the exponential growth of the Medicaid program.

**Section 5.** Appropriation – Medicaid Fraud Division – State. Regular salaries and personal services matching will change due to an increase in the maximum appropriation for salaries. The increase in both operating expenses and conference and travel corresponds to the increase in the number of employees for their office expenses and training.

- **Section 6.** Regular Salaries Medicaid Fraud Division Federal. These changes include an increase in the number of employees, an increase in the appropriation for salaries and title changes. Additional resources are necessary to combat potential fraud due to the exponential growth of the Medicaid program the same as in Section 4, *supra*.
- **Section 8.** <u>Appropriation Medicaid Fraud Division Federal.</u> Regular salaries and personal services matching will change due to the increase in the maximum appropriation for salaries. The increase in both operating expenses and conference and travel corresponds to the increase in the number of employees for their office expenses and training the same as in Section 5, *supra*. Modifications in this section also reduce the appropriation for extra help.
- **Section 9.** <u>Appropriation Medicaid Fraud Division Indirect Costs.</u> This increase is proportionate with the increases in regular salaries based on a mandated federal percentage.
- **Section 10.** <u>Appropriation Internet Crimes Against Children.</u> This technical correction changes the title of the section from "Internet Crime Child" to "Internet Crimes Against Children."
- **Section 11.** Regular Salaries Cooperative Disability Investigation Program. The modifications in this section include title changes as well as an increase in the maximum appropriation for salaries. This does not include any increase in personal services matching.
- **Section 12.** <u>Appropriation Cooperative Disability Investigation Program.</u> This is an increase in the maximum appropriation for salaries.
- **Section 13.** <u>Appropriation Cash Funds Settlement Fees.</u> The modifications in this section reduce the appropriation for cash settlement funds from \$25,000,000 to \$15,000,000, recognizing an additional savings of \$10,000,000. I also request that the title of this section change to Appropriation Cash Funds Unrestricted Settlement Fees, the phrase "fund transfers" be deleted from page 7 line 35 and the phrase "from unrestricted settlement fees" be added to page 7 line 36 after the word "activities."
