SECTION 35. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS EMPLOYMENT FIRST POLICY OFFICE - FUNDING. The Department of Commerce shall annually budget, allocate, and expend for the Arkansas Employment First Policy Office as appropriated in this act, the sum of at least five hundred thousand dollars (\$500,000) for personal services, operating expenses and outreach services to:

- (a) provide a framework for a long-term commitment to improving employment outcomes for individuals with disabilities in this state;
 - (b) encourage competitive employment as a preferred option for individuals with disabilities in this state;
- (c) encourage a collaborative effort between state agencies and organizations to achieve better employment outcomes for individuals with disabilities;
- (d) increase the number of individuals entering the workforce and contributing to Arkansas's tax base and economy; and
- (e) develop and administer the Employment First Business Partner Program.

The provisions of this section shall be in effect only from July 1, 2023 through June 30, 2024."
