JUSTIFICATION

DFA ABC is requesting the above position in order to ensure medical marijuana is properly regulated within the state. Currently, members of the legal staff within the division are assigned specific areas including alcohol, tobacco and medical marijuana. Due to the expanding medical marijuana industry, an additional Attorney Specialist, G047C, grade GS11, has been deemed necessary. This position will work with the existing medical marijuana focused staff member on a range of assignments including collaborating with permit holders regarding compliance issues, reviewing all new applicants and owners, responding to advertising questions and addressing patient requests with the assistance of the Arkansas Department of Health. This position will also be responsible for attending hearings regarding medical marijuana permit holder violations. The addition of the requested position is necessary for DFA ABC to issue reports and resolve facility violations in a timely manner. The Department of Finance and Administration (DFA), Alcoholic Beverage Control (ABC) Administration respectfully requests one (1) pool position from the growth pool.

The Alcoholic Beverage Control Administration employs four (4) Attorney Specialists. Two are assigned to alcohol-related issues, one is shared between alcohol and tobacco, while the other is assigned to medical marijuana. The current medical marijuana attorney is the sole attorney representing the state's interest in regulating marijuana.

The medical marijuana industry in Arkansas continues to develop, justifying the need for a second Attorney Specialist to serve as a point person for guidance and interpretation on rules and processes is apparent. The DFA ABC works diligently to successfully enforce statutory responsibilities. The Attorney Specialist works within a range of complex tasks to ensure compliance with medical marijuana regulations. These tasks require a combination of legal expertise, investigative skills, communication abilities, and the ability to navigate complex regulatory frameworks.

The additional Attorney Specialist will share the increasing workload and assist with facilitating licensing and renewals, working with attorneys or permit holders about compliance-related issues, strain name changes, advertising questions, vetting all new applicants or owners,

expansion requests, inventory reviews, and coordinating with the Department of Health on labeling and patient-centric requests.

This position will also share the responsibility of attending hearings on violations for permitholders related to medical marijuana. There are over 60 licensed marijuana facilities that are inspected regularly and with the potential for assessment violations. Without additional support, ABC will remain behind on issuing orders and resolving violations.

This position will be funded through medical marijuana funds.
