The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Labor & Licensing (ADLL), Contractors Licensing Board, for your review.

The ADLL, Contractors Licensing Board is requesting permission to advertise and fill position #22095701 authorized as X073C, DLL Contractors Board Investigator. This position has been vacant since 06-11-2017 and is being held due to Act 796. The agency currently has six (6) positions authorized as X073C, DLL Contractors Board Investigator, of which five (5) are occupied. The agency is reorganizing its territories within Arkansas due to an increase in construction. It needs to use all six (6) investigator positions in order to provide thorough coverage throughout all territories. The Contractors Licensing Board currently has seventeen (17) regular positions, none of the non-investigator positions are available to use as an investigator.
