Dear Senator Dismang and Representative Jean:

In the event that the 94th General Assembly of the Arkansas State Legislature approves any salary increases to the current Governor's Pay Plan:

The Arkansas Secretary of State's office respectfully requests the Regular Salaries and Matching funds of our current appropriation to increase at the same rate of that of the utilized by Executive Branch in order to remain competitive in the recruiting and the retention of qualified employees.

Outlined in HB1133, The Arkansas Secretary of State's office appropriation for 162 employees for Fiscal Year 2023-2024 is \$9,559,104. With additional 10 percent raise to the maximum line item for each position is as follows:



To give a 3 percent raise to every employee's salary, we will need an additional \$286,773 added to the current budget of \$9,559,104, making the total \$9,845,877. To raise the salary match by 3.43 percent to cover the 3 percent raise to every employee, we will need an additional \$118,429 added to the current budget of \$3,452,735 making the total \$3,571,164. The total amount appropriated will go from \$22,065,636 to \$22,470,837

The Secretary of State Office (SOS) respectfully requests to add sections 1 through 3 for our 2025 fiscal year. We would like to add sections 2 and 3(b) as a supplemental bill for our 2024 fiscal year.

- 1. New appropriation to the Secretary of State, to be payable from the State Central Services Fund for personal services and operation expenses for Capitol Police of the Secretary of State fiscal year ending June 30, 2024.

Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.

If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is overridden, it shall become effective on the date the last house overrides the veto.
