The Arkansas Supreme Court respectfully requests the following changes be made to its fiscal year 2024-2025 appropriation bill:



SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the Arkansas Supreme Court for the 2024-2025 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: five (5) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the Arkansas Supreme Court, to be payable from the State Central Services Fund, for personal services and operating expenses of the Arkansas Supreme Court for the fiscal year ending June 30, 2025, the following:
