Dear Senator Dismang and Representative Jean:

The Auditor of the State is requesting an amendment to Senate bill 54, the appropriation bill for the personnel salaries and operating expenses of Deputy Prosecuting Attorneys to make salaries of Deputy Prosecuting Attorneys comparable to other state employees as sent out in the new pay plan in SB392.

Currently, SB54 sets out eight different titles for Deputy Prosecuting Attorneys as set forth below, including current pay grade and the number of authorized positions for each title. We have included the new pay grade we would like assigned to each title.
