TRANSFER. If funds are not available for the State Board of Election

Commissioners to perform their duties, the Director of the State Board of Election Commissioners may from time to time certify to the Chief Fiscal Officer of the State the amount of funds needed and the Chief Fiscal Officer of the State shall transfer the certified amount from the Nonpartisan Filing Fee Fund to the Miscellaneous Agencies Fund for use by the State Board of Election Commissioners.

The provisions of this section shall be in effect only from July 1, 2021 through June 30, 2022.

SECTION 9. SPECIAL LANGUAGE — CODE AMENDMENT. Arkansas Code § 19-5-1225(b)(2), concerning the Nonpartisan Filing Fee Fund, is amended to read as follows:

(2) The fund shall be used to cover the cost of election expenses of the State Board of Election Commissioners as set out in § 7-10-101 et seq. and for personal services and operating expenses for the State Board of Election Commissioners."
