Page 2, line 25, delete "7" and substitute "15"

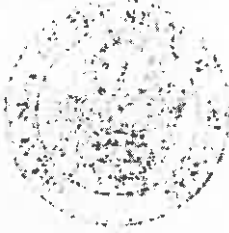
