Amendment No. to House Bill No. 1069

Amend House Bill No. 1069 as originally introduced:

Page 7 insert a new Section following Section 13 to read as follows:
"SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO
EXPENDITURE. The proceeds received by the Secretary of State's Office from
reimbursements for mandatory publications of petitions and measures and
deposited into the Mandatory Publication Reimbursement Fund shall be
transferred from time to time into the State Central Services Fund as a
refund to expenditure to reimburse the State Central Services Fund for costs
associated with mandatory publications.

The provisions of this section shall be in effect only from July 1, 2018 through June 30, 2019."

- 3 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE
- 5 CAPITOL POLICE. In the event that sufficient revenues, in the judgment of
- 6 the Secretary of State exist, the Secretary is hereby authorized to make
- 7 additional salary payments from such funds to those employees who have
- 8 attained law enforcement certification above the basic certificate level, as
- 9 defined by the Arkansas Commission on Law Enforcement Standards. It is the
