Amend Senate Bill No. 65 as originally introduced:

Page 29, insert an additional SECTION immediately following SECTION 52 to read as follows:

- " SECTION 53. SPECIAL LANGUAGE. DO NOT CODIFY. (a)(1) The Arkansas Economic Development Commission and the Arkansas Development Finance Authority shall file a final rule with the Secretary of State for adoption under § 25-15-204(f) to administer the Partnership for Public Facilities and Infrastructure Act, § 22-10-101 et seq., as required by § 22-10-503:
 - (A) On or before August 1, 2018; or
 - (B) If approval under § 10-3-309 has not occurred by
- August 1, 2018, as soon as practicable after approval under § 10-3-309.
- (2) The commission and the authority shall file the proposed rule with the Legislative Council under § 10-3-309(c) sufficiently in advance of August 1, 2018, so that the Legislative Council may consider the proposed rule for approval before August 1, 2018.
- (b) The commission shall use funds available in the State Operations
 Appropriation Section of this act to pay for any expenses required in
 connection with the adoption of rules under subsection (a) of this section."

days prior to the time the Agency, Board, Commission or Institution presents 1 its budget request to the Arkansas Legislative Council/Joint Budget 2 3 Committee; and (4) Thereupon, the Department of Finance and Administration shall include 4 all information obtained in item (3) above in the budget manuals and/or a 5 statement of non-compliance by the Agency, Board, Commission or Institution. 6 The provisions of this section shall be in effect only from July 1, 2017 7 8 2018 through June 30, 2018 2019. 9 10 SECTION 53. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency 11 and funds made available by law for the support of such appropriations; and 12 the restrictions of the State Procurement Law, the General Accounting and 13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 14 Procedures and Restrictions Act, or their successors, and other fiscal 15 control laws of this State, where applicable, and regulations promulgated by 16 the Department of Finance and Administration, as authorized by law, shall be 17 strictly complied with in disbursement of said funds. 18 19 SECTION 54. LEGISLATIVE INTENT. It is the intent of the General 20 Assembly that any funds disbursed under the authority of the appropriations 21 contained in this act shall be in compliance with the stated reasons for 22 which this act was adopted, as evidenced by the Agency Requests, Executive 23 Recommendations and Legislative Recommendations contained in the budget 24 manuals prepared by the Department of Finance and Administration, letters, or 25 summarized oral testimony in the official minutes of the Arkansas Legislative 26 Council or Joint Budget Committee which relate to its passage and adoption. 27 28 SECTION 55. EFFECTIVE DATE. This act is effective on and after July 1, 29 30 2018. 31 32 33
