Amendment No. \_\_\_ to House Bill No. 1009

Amend House Bill No. 1009 as originally introduced:

Page 14, line 9, insert the following new SECTION immediately following SECTION 21 to read as follows:

"SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REPORTING REQUIREMENTS - INTERNET SALES TAX COLLECTION. The Chief Fiscal Officer of the State shall file a quarterly report with the Bureau of Legislative Research Office of Economic and Tax Policy of all sales tax collections derived from internet sales. The report shall be due by the 15th day of the month following the end of each calendar quarter.

The provisions of this section shall be in effect only from July 1, 2018 through June 30, 2019."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES. There is hereby established for the  
25 Department of Finance and Administration - Management Services Division for  
26 the 2018-2019 fiscal year, the following maximum number of regular employees.

1 Grants in an amount determined by the Chief Fiscal Officer of the State.  
2 Any unexpended balances in funds provided for Department of Justice Non-  
3 Victim Assistance Matching Grants in this act remaining on June 30, ~~2017~~  
4 2018, may be carried forward and used for the same purpose during the fiscal  
5 year ending June 30, ~~2018~~ 2019.

6 The provisions of this section shall be in effect only from July 1, ~~2017~~  
7 2018 through June 30, ~~2018~~ 2019.

8  SECTION 22. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
9 authorized by this act shall be limited to the appropriation for such agency  
10 and funds made available by law for the support of such appropriations; and  
11 the restrictions of the State Procurement Law, the General Accounting and  
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
13 Procedures and Restrictions Act, or their successors, and other fiscal  
14 control laws of this State, where applicable, and regulations promulgated by  
15 the Department of Finance and Administration, as authorized by law, shall be  
16 strictly complied with in disbursement of said funds.

19 SECTION 23. LEGISLATIVE INTENT. It is the intent of the General  
20 Assembly that any funds disbursed under the authority of the appropriations  
21 contained in this act shall be in compliance with the stated reasons for  
22 which this act was adopted, as evidenced by the Agency Requests, Executive  
23 Recommendations and Legislative Recommendations contained in the budget  
24 manuals prepared by the Department of Finance and Administration, letters, or  
25 summarized oral testimony in the official minutes of the Arkansas Legislative  
26 Council or Joint Budget Committee which relate to its passage and adoption.

28 SECTION 24. EFFECTIVE DATE. This act is effective on and after July 1,  
29 2018.
