Dear Mr. Rand:

These comments on proposed amended Rule 111 are submitted on behalf of Dean McNeel DDS and Ozark Prosthodontics in response to the Amended Notice of Public Hearing issued January 31, 2022, and in anticipation of the public hearing scheduled for February 24, 2022. Please submit them as part of the record at the hearing.

The stated purpose of Act 955 of 2021 is to "serve residents in this state who are in need of healthcare services to treat individuals with craniofacial anomalies." [Act 955, Emergency Clause.] The statute requires Health Benefit Plans to include coverage and benefits for reconstructive surgery and related medical care for a person diagnosed as having a craniofacial anomaly if the care is medically necessary to improve a functional impairment "as determined by a nationally approved cleft-craniofacial team, approved by the American Cleft-Palate-Craniofacial Association in Chapel Hill, North Carolina." Arkansas Children's Hospital (ACH) has the only ACPA approved team in Arkansas, and that, unfortunately, has created a bottleneck that restricts access to critical services for patients with a craniofacial anomaly. However, the bottleneck at ACH cannot be remedied through Rule 111.

Nevertheless, the Department can further the goal of the statute through its promulgation of Rule 111, and the proposed Rule 111 published on January 31, 2022, does so. My clients

Thank you for making me aware of this February 24, 2022 2nd Public Hearing on Rule 111 at 1:30pm.
