Arkansas Code § 6-21-813 School Facility Inspections – Division Responsibilities

The Division of Public School Academic Facilities and Transportation shall:

- (a) Conduct random unannounced on-site inspections (Onsite Inspections) of all academic facilities to ensure compliance with the school district's facilities master plan and, if applicable, the school district's facilities improvement plan in order to preserve the integrity of and extend the useful life of public school academic facilities and equipment across the state.
- (b) **Submit reports** regarding its on-site inspections of academic facilities to the Commission for Arkansas Public School Academic Facilities and Transportation.
- (d) Work with state agencies and commissions requesting inspection assistance for those areas in which the state agency or commission has primary responsibility to conduct lawfully required inspections.
- (e) Work with school districts, state agencies, and state commissions to ensure that all lawfully required inspections of academic facilities are performed (State Mandated Inspections)
- (f) Work closely with the school district and the appropriate state agency or commission, if an inspection or code violation is reported in the course of an inspection or re-inspection, to **ensure the violation is remedied within thirty (30) days** of the date the inspection or code violation is reported or as soon as reasonably possible thereafter.

Arkansas Code § 6-21-813 State Mandated Inspections – District Responsibilities

(e)(1) All lawfully required inspections of academic facilities include without limitation scheduled, unscheduled, or emergency inspections of or concerning:

- a. Boilers
- b. Electrical systems
- c. Heating, ventilation, and air conditioning systems
- d. Natural gas piping systems
- e. Liquid propane gas systems
- f. Plumbing systems, including without limitation reduced pressure zone valves
- g. Indoor air quality systems
- h. Fire prevention
- i. Elevators
- j. Occupational safety and health issues
- k. Water wells
- I. Asbestos, and

School Facility Maintenance

- Arkansas Code § 6-21-808(d) requires districts to "dedicate nine percent (9%) of its foundation funding exclusively to payment of utilities and costs of custodial, maintenance, repair, and renovation activities, which include related personnel costs, for public school facilities."
- Arkansas Code § 6-21-808(c) requires districts to use the state's computerized management maintenance system (Operations Hero).
 - School district use of the computerized management maintenance system shall include without limitation:

(1) Entering and tracking all reactive and preventative maintenance work;

- (2) Entering preventative maintenance schedules for academic and nonacademic facilities' systems;
- (3) Documenting completed reactive and preventative maintenance work; and
- (4) Scheduling state-mandated inspections as required under § 6-21-813(e);

School Facility Property Insurance

- CAPSAFT Rules Governing the Academic Facilities Partnership Program (2023), Sec. 5.07, states: "Every academic facility must be insured and remain insured for 100% of replacement cost to be eligible for state financial participation."
- CAPSAFT Rules Governing Property Insurance Requirements (2007), Sec. 4.02, states: "Each school district shall ensure that coverage shall be provided for all school district buildings, structures, and business personal property at each described location and identified on a statement of values unless otherwise scheduled. Any school district building, structure or business personal property not insured for at least 90% of replacement cost shall not be eligible, for purposes of facility assistance, for any state facility funding assistance administered by the Arkansas Commission for Public School Academic Facilities and Transportation.
