Responses to the following questions are due via email to Subcommittee staff no later than the 15<sup>th</sup> of the month immediately preceding the month the occupational authorization is scheduled for review by the Subcommittee.

# 1. Would consumers be at risk of substantial harm if Arkansas did not have this occupational authorization?

Yes, due to the physical properties of propane and its common uses today, substantial harm, including death could result from untrained individuals providing installation, transportation, and handling of Liquefied Petroleum (LP) Gas.

What instances of specific and substantial harm have been documented in the past year?

The National Fire Protection Association has reported that nationally propane is the cause of 2900 residential fires annually that result in 25 civilian deaths and 155 civilian injuries. In addition, the Consumer Product Safety Commission has reported an average of 600 fires nationally involving propane grill cylinders that resulting in 30 civilian injuries annually. Over the last 12 months there were 4 reported incidents involving propane in Arkansas:

2/2/2023 – A transport traveling west on 306 northeast of Cotton Plant left the road and overturned. There was no release of product. The driver was unharmed. There was damage to the tractor and trailer and minor property damage.

5/8/2023 – An unintended release of propane occurred at a farm located in Crittenden County. No damage was reported. The dealer responded, isolated, and repaired the leak.

7/17/2023 – An unintended release of propane occurred in Baxter County when a vehicle left the road impacting a 500-gallon propane tank located at a residence.

Approximately 150 gallons of propane was released. Minor property damage was reported. The dealer responded, repaired the plumbing and reset the tank.

11/2/2023 – An unintended release of propane resulted in an explosion at the

Doughboy manufacturing facility located in West Helena. An employee overfilled

a forklift cylinder causing the relief valve to discharge resulting in a fire. The fire

impinged on a propane cylinder causing the metal to weaken which resulted in a boiling liquid expanding vapor explosion. The incident resulted in one employee being transported to Memphis for extensive burns. Two forklifts were consumed in the fire as well as the refueling site.

We are aware that many additional incidents occur every year that are not reported to the LP Gas Board (Board), including incidents with grill cylinders and 1-lb disposable cylinders where the consumer does not have a relationship with a dealer and would have no reason to report.

# 2. How many complaints were made to the occupational entity by consumers being harmed by unauthorized practitioners?

Because we require the dealer to inspect and perform a pressure test prior to placing a system into service, nearly all inferior work that may result in harm or injury is discovered and repaired. We received roughly a dozen complaints during 2023 involving piping installations performed by plumbers and electricians not certified by the Board. The complaints came from consumers and our Class 1 Dealers who discovered issues prior to placing a system in service. An individual who holds a master plumbers license from the state is not required to be certified by the Board. No electrician can legally provide plumbing installations of LP-Gas. These electricians were expediting the installation of backup generation.

#### What specific action was taken by the occupational entity?

When a licensed master plumber is involved, we work with the plumber and our Class 1

Dealer to repair or fix the issue prior to the Class 1 Dealer placing the system in service.

In the event that the issue is with an electrician we train them in proper plumbing installation and then permit the company and certify their employees.

3. How many complaints were made to the occupational entity by consumers being harmed by <u>authorized</u> practitioners?

Over the past 12 months we have documented 15 complaints involving permit holders.

These complaints range from pricing concerns to tanks not being picked up when requested to cylinders being overfilled.

### What specific action was taken by the occupational entity?

If the complaint is financial in nature, such as pricing or billing, we refer the consumer to the Attorney General's consumer complaint division. The LP Gas Board does not have statutory authority over these financial issues. The majority of the complaints we received involved tanks that were not picked up for an extended amount of time following request from the consumer. In these cases, we notify the Class 1 Dealer and request they pick up their tank. We received one complaint regarding overfilling of a cylinder.

Overfilling a cylinder is very dangerous. In this case it involved a Class 3 Dealer (Cylinder Refilling Permit). We suspended the permit and required all certified employees to be retrained and retested.

- 4. Were any applicants who otherwise met authorization requirements denied an authorization in the past year? *No* If so, why? *N/A*
- 5. How much does the occupational entity collect annually in fees, and what are annual expenses?

Historically the Board's revenue has exceeded expenses by around \$100,000 annually.

- 6. If the occupational entity has a positive amount in reserves, when was the last time reserve funds were used? <u>2019</u> For what purpose? <u>Vehicle Replacement</u>
- 7. Does the occupational entity have any other sources of revenue? <u>No.</u> Could occupational authorization fees be reduced without causing the occupational entity to be underfunded?
  - Yes. In 2023, Secretary Khoury, the Board, the legislature, and the Governor's Office collaborated on a bill to clarify the existing statute that allows the Board to suspend certain fees when the Board has sufficient funding in reserves (Act 349). The Board voted during the June 2023 board meeting to suspend all inspection and registration fees for FY24. Board received a report at its December meeting that this action had already resulted in a savings of \$100,000 to the industry. It is estimated that by the end of FY24, the industry will have saved \$250,000 as a result of the suspension.
- 8. How many applicants for the occupational authorization fail each year?

  None. In the past, individuals have withdrawn their application for a permit, but the
  Board has never voted or denied the issuing of a permit if all requirements are met.

  Does the occupational entity track how many applicants that do not progress are
  veterans, women, or minorities?

  No. As mentioned above, this does not happen.
- 9. Can applicants complete the training requirements for this occupational authorization with vocational or non-traditional education (e.g., apprenticeships)?

  Yes. What percentage of applicants complete apprenticeships? 100%. We require on the job training of 30 days prior to certification. All applicants complete certification with the exception of those who resign or are terminated by the permit holder prior to the 30 days.
- 10. In what ways would removal of the occupational authorization or reduction of occupational authorization requirements be harmful to current authorization holders?

Removal of occupational authorization would likely be harmful to current holders. Many dealers have worked to establish their business for many years and their ownership is

often generational. Removal or reduction of authorizations could have a substantial financial impact on the dealer's ability to train and retain qualified personnel and training, as well as participate in safety equipment and consumer awareness programs.

Any incident involving propane does not just affect the responsible party but the industry as a whole. As incidents occur in greater frequency due to untrained or undertrained personnel, the financial impact would increase on those who have established businesses.
