
History

- Segal recommended that EBD conduct a bid for a Medicare Advantage Prescription Drug (MAPD) Plan as apart of the work with the BLR in 2021
- Recommend a side-by-side approach that would generate savings on a cash and OPEB liability basis
 - Market analysis conducted where preliminary rates were provided from two major carriers
 - Estimated savings of \$20.9M for plan and \$12.6M for ASE
 - Estimated \$4M in additional premium for PSE, however now receive an exceedingly rich prescription drug plan that was taken away
 - Assumed retiree contribution percentage consistent with prior splits and assumed 75% participation
- Recommendation was adopted and RFP was done for the new plan effective January 1, 2023

Arkansas Medicare Retiree Rates


2023 Health Advantage vs. MAPD

- The competitive RFP yielded rates even better than initially gathered from the market analysis of \$257 PMPM.
- The \$85 MAPD rate for PSE includes prescription drug benefits, while the \$238 rate for the Health Advantage plan is medical only.






