# **JUSTIFICATION**

Three (3) of the positions being surrendered are currently filled by employees who are functioning as telecommunications specialists, and one (1) who is functioning as a telecommunications supervisor. To keep these employees performing their critical functions, DPS believes that it is appropriate to request these pool positions requested during the biennial but skipped during the session. Surrendering one (1) position that is currently vacant and unfilled creates additional net savings for this request.

# **RECOMMENDATION**

The Office of Personnel Management has reviewed this request from the Department of Public Safety and **recommends** the requests to obtain four (4) positions and the surrender of five (5) positions to the OPM surrender pool. This approximate cost of these positions is \$19,905. The department guarantees it possesses the funds to execute this request.


