DPS is requesting the above position to meet the needs and improve communication efforts within the department. The requested position will be responsible for coordinating constituent services for ASP, coordinating a recognition of ASP fallen officers, and developing and updating social media and website content. The position will be the point of contact for ASP events, such as troop school graduations and awards banquets, develop and distribute an ASP employee newsletter and create and update content for ASP intranet features.

This position will be responsible for reviewing all related social media content, Facebook Messenger conversations, and WeTip Hotline tips, for questions, complaints, tips about crime, fugitive locations, Amber alerts, Silver alerts, and child abuse to ensure that these content related to process accordingly. The anticipated cost of this growth pool request is approximately \$51,758 including matching.

- Coordinate constituent services for Arkansas State Police .
  - Take and return calls and respond to emails and social media messages. Constituents have a myriad of 0 questions, concerns and tips and sometimes report active criminal activities and abuse. Providing professional and courteous customer service to our constituents is paramount.
  - Monitor and respond to comments and messages received on social media platforms
  - Draft and seek approval for responses to hot topic constituent feedback/questions to provide other ASP 0 public points of contact, such as Troop dispatchers
- Coordinate recognition of ASP fallen officers
  - End of watch anniversary emails and social media posts
  - Communications point of contact for annual ASP memorial event
- Development and update social media and website content
- Communications team point of contact for ASP events, such as troop school graduations, annual awards banquet
- Develop and distribute an ASP employee newsletter ٠
- Create and update content for ASP intranet features

ASP receives over 2,000 new Facebook Messenger conversations, approximately 900 followers on Facebook, and 20 to 30 WeTip Hotline tips per month. This position will be responsible for reviewing all of the questions, complaints, tips about crimes, fugitive locations, Amber alerts, Silver alerts, and child abuse. Sorting through the different social media platforms to ensure that these are all captured and processed accordingly is a very high priority and the requested position will be dedicated to this work.
