# **JUSTIFICATION**

TSS is requesting the above positions in order to resolve recruitment and retention issues within the State Surplus section of the department. Arkansas State Surplus is responsible for managing the sale and redistribution of state surplus property. Currently, this division is experiencing difficulties obtaining all surplus items due to the inability to recruit and retain employees. Within the last year, three employees have left the department along with two more employees actively searching for employment elsewhere due to salary issues. In order to qualify for employment within the requested new classifications, applicants must be in possession of a commercial driver's license (CDL) prior to employment. This new requirement will save the division valuable time by allowing the employee to begin work after a short orientation rather than spending time training and obtaining a CDL. Approval of the requested positions will establish a career path for employees within this division which will encourage employees to stay with the department long term. Approval of this request will result in an anticipated cost of approximately \$43,834, including matching. This amount accounts for promotions of nine (9) current incumbents within the surrendered positions.

#### RECOMMENDATION

The Office of Personnel Management has reviewed the request and recommends the approval of ten (10) surrender pool positions.

Arkansas State Surplus is experiencing an increase in demand for services. Last biennium, the State Surplus division generated \$6.1 million in revenue for the State of Arkansas and expects to do more in the next biennium. State Surplus has multiple departments on a backlog to pick up items from across the state, and this backlog is due to State Surplus being unable to recruit and retain employees. State Surplus has lost three employees in the last year, each leaving for more money, creating a turnover rate of 12.5%. State Surplus has two employees currently searching for new employment due to their rate of pay and our current economy.

Additionally, employees are required to have a CDL Class B license. Hiring someone that doesn't have a CDL Class B license requires State Surplus to wait for them to do training, for which the employee must also pay \$900 to take the course and get the license if they don't already have one. The current employment market rate for a CDL Class B driver starts at around \$45,000-\$50,000.

State Surplus is also requesting a new GS10 to create equity in the department. The current manager is a GS08 and will supervise two GS08 employees. With this update from a GS08 to a GS10, State Surplus can show a clear line of progression and career growth within the division. The Department of Transformation and Shared Services believes this change will help retain employees and help recruitment along with the other benefits the State of Arkansas offers.

Arkansas State Surplus is a cash agency and receives no general revenue funding. State Surplus can cover the additional expense for the requested positions, and we believe they are needed to run the department efficiently. The Department of Transformation and Shared Services respectfully requests the creation of one (1) GS10 TSS Division Manager, one (1) GS08 TSS Surplus Property Supervisor and eight (8) GS06 TSS Surplus Property Agent positions and to surrender eight (8) GS04 Surplus Property Agent positions, one (1) GS06 TSS OSP Surplus Property Supervisor, and one (1) GS08 Program Fiscal Manager.
