The Arkansas Department of Military (DOTM) requests approval to obtain the five (5) 100% federally funded positions listed below and surrender fifteen (15) positions listed below.

DOTM submitted five (5)-positions to be retained during a review of positions that had been vacant for two (2) years or more in accordance with Act 796 of 2021, ACA 21-5-226. Due to an oversight at the DOTM, these positions were left off the final list submitted for retainment. Two of the positions below will enable the Agency to reestablish security supervisor positions that are a higher grade than the regular security positions. The GS01 Housekeeper position is currently needed to address operational needs. The GS07 Military Facilities Supervisor is required at the Fort Chaffee Joint Maneuver Training Center to enable a supervisory chain in the warehouse unit.
