### JUSTIFICATION

The Arkansas Department of Labor & Licensing (ADLL) possesses a legal division. This legal division contains four (4) positions, of which two (2) are occupied by licensed attorneys. One (1) of these licensed attorneys will transfer out of the department soon. ADLL needs a position authorized as a classification that can entice an experienced attorney. This position is primarily responsible for providing legal services and advice to all board directors within the department by interpreting laws pertaining to each board and conducting legal research. Its supplemental responsibilities include drafting legal briefings, pleadings, responses to subpoenas, policy, legislation, and rules.

### RECOMMENDATION

The Office of Personnel Management has reviewed this request from the Arkansas Department of Labor & Licensing and recommends the establishment of one (1) surrender pool position authorized as G004C, Managing Attorney. The cost for this one (1) surrender pool position is approximately \$11,494.10. The agency guarantees our office that it possesses sufficient funding to support this surrender pool position request.
