Dear Senator Davis and Representative Berry,

The University of Arkansas Community College at Batesville (UACCB) respectfully requests the approval, pursuant to ACA 21-1-402(b), to employ Ms. Tammy Pearce in a state-appropriated "Extra Help" position. Ms. Pearce is the spouse of Arkansas State Representative Shad Pearce, who began serving the 40th District of Arkansas in the House of Representatives on January 1, 2023.

Currently, UACCB has a full-time person designated as the Director of Foundation. This individual has requested part-time status to accommodate family commitments. To maintain the efficiency of our operations, we propose using approximately \$77,000 in funds budgeted for the full-time position to create two part-time positions: a part-time Director of Foundation at 15 hours per week, and a part-time Director of Development at 25 hours per week. Both positions will pay \$35 per hour. The foundation position will focus on internal management of funds, while the development position will focus on the external solicitation of gifts to support the college and our students.

Provided our request is approved, it is our intent to employ Ms. Pearce as the Director of Development. Ms. Pearce possesses a Bachelor of Science in Business and has a wealth of experience in business development at two Batesville area banks. She has likewise served on the Independence County Quorum Court and the UACCB Board of Visitors. She is a well-connected and well-respected member of our community, and we believe her qualifications make her the ideal candidate for this position.

We respectfully request this matter be added to the January Personnel subcommittee agenda for your consideration. We believe Ms. Pearce's appointment will greatly benefit UACCB and its mission to improve the lives of our students.
